Cllr I Douglas introduced Alistair Duncan from Haltec Associates who went onto explain about the recent application for a Lawful Development Certificate at Tagedale Quarry, he explained what the certificate was and also gave a history of the planning issues around Tagedale Quarry over the years. Cllr I Douglas gave an overview of the lack of planning enforcement by NULBC over the years in relation to this organisation.

**It was agreed that members would think about whether a letter should be written to NULBC regarding lack of planning enforcement and report back at next month's meeting.**

A requirement for a public meeting was discussed and it was agreed at this stage it was too premature, however, it was decided that a briefing would be held for the handful of individuals who had expressed and interest in knowing about the situation at Tagedale Quarry.

Cllr J Vallings raised concerns about a development at Pipegate which was under Shropshire Council.
